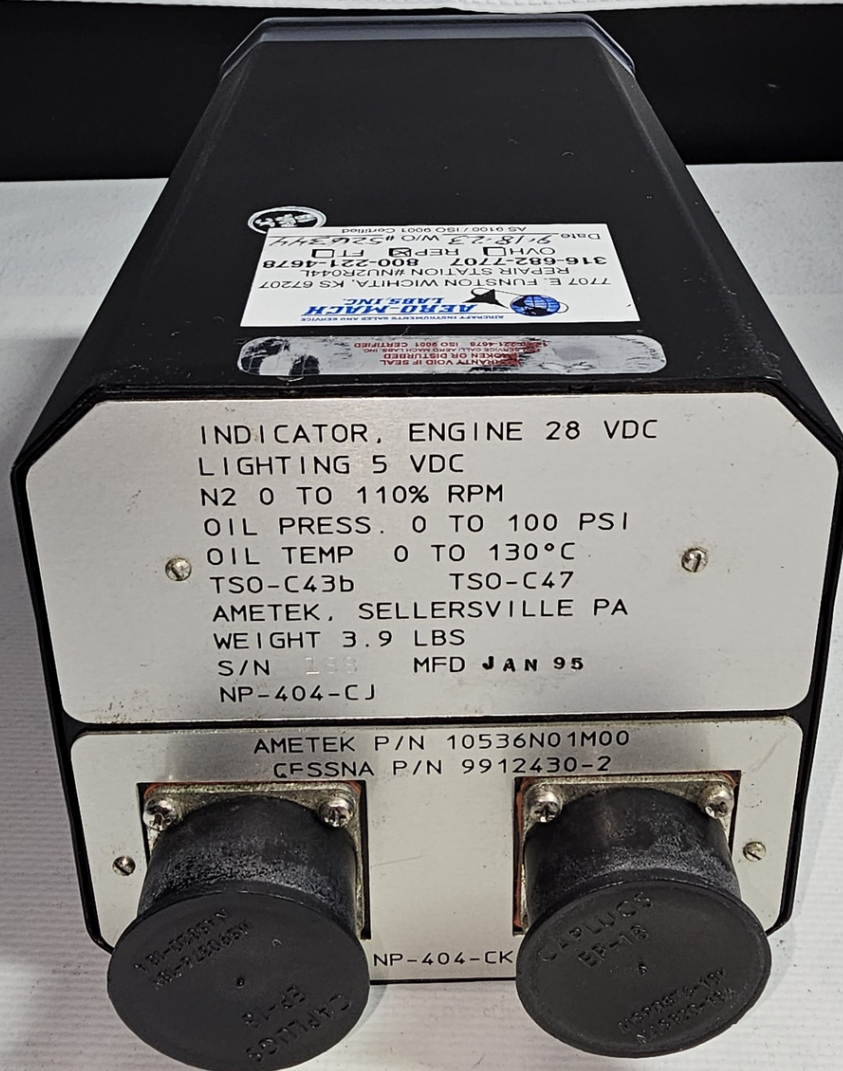

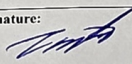

User/Installer Responsibilities
